


General Meeting

The Secret Lives of Feathers **Presented by Stewart Janes**

November 16, 2023 7:30 PM

Feathers are by far the most complex structure produced by the skin of any animal. Hair and scales don't come close. The story becomes more amazing when you learn how feathers grow, how different shapes are produced, how patterns such as stripes and bars are embedded into the growing feather and the many ways colors are incorporated. I invite you to come learn more about what makes birds even more special than you may already appreciate.

Stewart Janes is a retired biology professor from Southern Oregon University. He has spent many enjoyable years in the field studying raptor ecology in the intermountain west of North America and later studying the function of birdsong focusing on Hermit, Townsend's, and Black-throated Gray Warblers. The latter started as a small project that took him down the rabbit hole for much of his career. Who knew how complex the song systems of these birds would prove to be, and he continues to work to unravel the problem in retirement. Stewart was raised in the Portland Audubon Society. He fledged to earn his B.A. at the University of Montana, his master's degree at Portland State University, and his PhD at



UCLA. He was thrilled to be able to return to Oregon for his career which involved teaching ornithology and science teachers, and coordinating the Environmental Education master's program at SOU.

Conservation News

Elliott State Research Forest

Legislation allowed the creation of the largest research forest in Oregon, with OSU College of Forestry managing what is now the Division of State Land ownership, under supervision by a governor-appointed Elliott Forest Authority. The 800+ page forest management plan released on October 8th for public comment has been extended to November 8th. Recent significant changes concern both the conservation community and College scientists. Planning delays have created an extremely compressed time frame for public comment, in part because under that legislation the entire scheme expires if the Plan and its accompanying federal HCP + incidental take permit are not finalized before 2024. ASC plans to endorse comments by the conservation community.

Floating Off-shore Wind Development

ASC has endorsed an extensive comment being finalized by conservation, fishery, and tribal groups to the Bureau of Ocean Energy Management, and will also make that final comment available on our website.

Western Pond Turtles Are in Trouble

Long a species of concern across Pacific coast states, on Oct 3rd the US Fish & Wildlife Service determined both recently split Northwestern and Southwestern Pond Turtles are now threatened species. Read more here.

Corvallis Forested Watershed Losing Its Water Supply

Yes, drier and warmer summers can reduce summer water supplies, but older intact forests, even without a summer snowpack, moderate stream flows by

storing and then releasing more water through longer periods of drought. The cyclical growing and harvesting of trees, used by the Siuslaw National Forest and the City of Corvallis in the Rock Creek watershed, still practice forestry to produce wood and revenue not water or biodiversity. This must be replaced by management focused on producing the



highest quality water at the lowest cost, rather than the most water regardless of treatment cost. This transition would restore lost biodiversity and begin decreasing the city's significant carbon footprint.

Creating a Bird-Friendly Community

Oregon's Audubon Chapters are meeting to develop a community recognition system across our state. Like the Tree City and Bee City programs, there are many activities municipalities can encourage, model, and support to highlight their bird-friendliness. Criteria will be developed to evaluate how a community meets or exceeds threshold requirements to be certified. We can model how our community reduces the big threats to birds of outdoor cats, night lighting, and building strikes, or show how landscaping, native plantings, and even bird feeding methods can contribute to avian well-being. Atop the Nest Box

2023 Bluebird Trail Nesting Report

The 2023 nesting season for Western Bluebirds in the Willamette Valley ended about two months ago. In the nest boxes monitored by Bluebird Trail volunteers in Benton and Linn counties this year, the first bluebird egg was laid around April 15, and the last chick fledged (i.e., left its nest) around September 10. Table 1 summarizes the nesting data from 2023 and the average nesting data from the years 2009–2022.

Table 1	2023	Average, 2009–2022
Nesting attempts	154	222
Eggs laid	767	1,095
Eggs laid/nesting attempt	5.0	4.9
Eggs hatched	589	863
% Eggs hatched	77	79
Chicks fledged	492	734
% Chicks fledged	84	85

In Table 1, a nesting attempt is defined as a nest that contained at



least one bluebird egg. You can examine the year-by-year data from 2009–2023 on the ASC website: auduboncorvallis.org/bluebird-trail.

What can we make of the data shown in Table 1? First, note that the number of nesting attempts in 2023 was much lower than the 2009–2022 average. Was this decrease simply a result of fewer volunteers collecting data from fewer nest boxes? We can answer this guestion by looking at the number of nesting attempts per monitored box. This year's 154 nesting attempts were recorded in 362 monitored boxes, giving a ratio of 0.43 nesting attempts per box. As Table 2 shows, there has been a decline in this ratio since 2021. (I don't have the information needed to make this comparison for prior years.) Thus, it appears that bluebirds have been nesting less frequently in the boxes we monitor, at least over the past three years.

What might be causing bluebirds to nest less frequently in our boxes? Perhaps they're losing out in the competition for boxes with Tree Swallows, Violet-green Swallows, House Wrens, or other cavity-nesting birds. Alternatively, there could be a reduction in the availability of food (mainly insects) that bluebirds need before they begin nesting. However, the Bluebird Trail doesn't collect quantitative data on nest box use by other species or hunting success by bluebirds, so we can't test either of these hypotheses.

Despite the recent decline in bluebird nesting activity in our boxes, the number of eggs laid per nesting attempt, the percentage of eggs that hatched, and the percentage of chicks that fledged in 2023 were very close to the 2009–2022 averages (see Table 1). In other words, when bluebirds did build nests and lay eggs in our boxes this year, those nests were about as successful as the nests built during the preceding 14 years, on average.

Corvallis Christmas Bird Count

The first Corvallis CBC was held on December 26, 1912. The second count was not held until 1962, and the CBC has been held every year since then. The Corvallis CBC is traditionally held on the Tuesday before Christmas. Everybody is invited – and participation is free. The count is within a 7.5-mile radius circle, centered near the Corvallis airport. It is usually divided into 13 sections, with a team of 3-6 individuals assigned to each section. Team leaders provide additional information about what to bring and where to meet. Home or bird feeder counters are also welcome.

The next Corvallis CBC will be held on Dec. 19, 2023. If you would like to participate as a counter in one of the sections, please contact Bev Clark before the count date. Team leaders for each section will make arrangements with the rest of their group for a meeting place and time (usually between 7:00 and 7:30 AM the morning of the count). Participants should bring cold- and wet-weather gear, binoculars, a scope if you have one, and snacks for the day. A notepad and pencil or electronic recording devices, field guides, a camera, and a thermos with something hot are always good ideas as well.

authority to determine policy from the Public Works Dept. and are in discussion with journalists interested in telling the story of municipal water supplies across the Oregon Coast Range. Planners came up with several management strategies for the McDonald-Dunn Forest Plan. Within each of those there could be different scenarios across the landscape. Over the summer, the College farmed out the first computer modeling effort of what these alternatives might look like. Delays have held up any review by the two advisory bodies appointed to this work. Release for public comment now looks to be after mid-November. These delays further compress any period for reasonable community evaluation. I continue to serve on the Stakeholder Advisory Committee as a representative for ASC. The Forest Management Plan for the Elliott State Research Forest was released Monday, with comments due October 27, 2023. Oregon Audubon Chapter activists Joe Liebezeit (Portland) and Ann Vileisis (Kalmiopsis) asked for other Chapter endorsements in requesting a comment period extension on floating offshore wind energy development, regulated by the federal Bureau of Energy Management.

Diversity, Equity, and Inclusion Committee: Sent an email to NAACP requesting sponsorship of the January MLK Day Walk. Corvallis Sustainability Coalition already signed on.

Hesthavn: Linnea Birdwell runs young kids' program on Weds AMs. Would like a tour of Barn and set date Nov 15th at 10:00. Volunteers needed. Considering replacement of sign in the parking lot.

Field Trip Committee: Meeting planned for the end of November.

Sustainability Committee: Attended quarterly CSC meeting. There were many great presentations. The next event is in March. Suzanne would like to get someone new involved to train as a replacement.
