Conservation News

The 64th Annual Christmas Bird Count

The Corvallis Christmas Bird Count (CBC) will be held on Tuesday, December 17, 2024. Everybody is invited to join, and participation is free. The Corvallis CBC is part of an organized, continent-wide survey that documents every bird seen or heard on a given day. It has been held yearly since 1900, making the count a major contributor to the knowledge base of wintering birds in North America. The count is coordinated by the National Audubon Society, and results can be found at <u>www.audubon.org/conservation/science/christmasbird-count</u>.

This all-day event is an excellent opportunity for novice bird watchers to join with seasoned veterans and learn more about identifying and finding local birds. Half-day participants and home-feeder watchers are very welcome. If you live within the <u>count circle</u>,

have home feeders, and can watch them for at least one hour on the count day, we especially encourage you to participate. A fillable form is available from Bev Clark

(clark.bev9@gmail.com) for this purpose. Some counts, particularly in Canada, are mostly made up of home-feeder watchers.

The Corvallis count circle has a 7.5-mile radius centered near the Corvallis airport and is divided into 13 sections. A link to a map of the count circle is <u>posted on the ASC website</u> on

the Bird Surveys page. A team of 3-6 individuals will be assigned to each section. Leaders for each section will make arrangements with the rest of their team for a meeting place and time (usually 7:00–7:30 am) on the day of the count. Participants should bring cold- and wetweather gear, binoculars, a spotting scope (if you have one), and snacks. Notepads, a clipboard, and recording devices are necessary to document the count. The use of eBird is widely used and preferred to document bird sightings.

At 5 PM on the count day, we will meet for the "countdown" at the Corvallis Community Center, located at 2601 NW Tyler Ave. Chili and condiments will be Mai and Eric, Program Committee

Matt will compile the data, which will be sent to the National Audubon Society Christmas Bird Count and posted on the MWBA (ASC) website. Bev will work with anyone who finds rare or unusual birds to have them properly documented.

Board Meeting Summary

November 14, 2024, 7 PM

Attending: Phyllis Bailey, Mark Baldwin, Bev Clark, Ray Drapek, Bill Gellatly, Mai Kiigemagi, Dave Mellinger, Suzanne Ortiz, Carolyn Peterson, Jayshaun Talbot, Dodie Wilson.

REPORTS FROM OFFICERS

VICE PRESIDENT: Mai Kiigemagi reported that Carl Lucker, the staff person at the Corvallis Community Center (C3) has taken a new job. C3 will be hiring his replacement, but it is not known if the new staff person will want to volunteer to assist MWBA (ASC) with the audio-visual presentations at the monthly meetings.

TREASURER REPORT: Summary provided by Carolyn Peterson. Carolyn has submitted paperwork to the State of Oregon that initiates the "assumed business name registration." The State will send the forms that need to be completed and sent to the IRS. This step takes approximately 8-9 weeks.

COMMITTEE REPORTS

EDUCATION REPORT: Dodie has changed our Facebook name to MWBA. She has participated in discussions with Anya Ballinger from the Benton County Historical Society about the museum exhibit related to bird conservation and fashion/feathered hats from the 1880s to the early 1900s. The exhibit will open in March 2025. Jayshaun Talbot, Marcia Cutler, and Dodie have agreed to be on the committee. They will determine what the museum would like MWBA to contribute.

Dodie reported that the Education Team will volunteer at Family Fun nights. The first event will take place on January 3 from 5-7 PM on the theme "Nocturnal Owls." Jayshaun volunteered to work with the Education Team.

CHAT: In an email earlier today, Jake Keen asked about the payment to MailChimp; Carolyn will follow up with Jake on this.

CONSERVATION: Dave Mellinger acknowledged the passing of Bob Salinger, a dedicated and long-time advocate for conservation issues throughout Oregon.

Dave mentioned that he has recently become aware of a Motus Tower near Finley NWR; Bev will inquire at Finley HQ for more information about the tower's location. In a follow-up email dated 11/16/2024, Bev Clark provided an update to the MWBA board from Sam Bartling. The NWR had indeed set up a Motus "test tower" determining where to place the tower. Following the test, a decision was made to place the Motus Tower at Pigeon Butte. They expect it to be in operation in the next 3-6 months.

Ray Drapek attended the OAC Conservation Meeting that was held on 10/26/2024 at Ankeny NWR. Ray presented a report at the meeting on MWBA's conservation activities. He also reported on the status of the MWBA/ASC name change. He gave the MWBA board a summary of the 2024-2025 Priorities as discussed at the meeting:

- Priority #1: Oregon border wetlands. Discussed expanding "wetland" to an over-arching category beyond border areas (Malheur, Klamath, and Lake Abert).
- Priority #2: Forests Federal (NWFP), State (Elliott) and private. All chapters are working on this. Paul Englemeyer, the TenMile Sanctuary Manager has offered to talk to Oregon Chapters on the 30 x 30 plan protecting 30% of Oregon by 2030); this will remain a Tier 1 Priority in 2025.
- Priority #3: Oceans and Coastlines. Includes rocky habitats, estuaries, and offshore wind. This will be a Tier 2 Priority.
- Priority #4: Imperiled Bird Species. Includes Western Snowy Plover, Northern Spotted Owl, Marbled Murrelet, Sage Grouse and Streaked Horned Lark. This will be a Tier 2 Priority.
- Priority #5: Reducing Avian Threats/Hazards. Includes window strikes, light pollution, drones, and cats; bird safe communities. Will be a Tier 2 Priority.

- Priority #6: Coexistence strategies (includes beavers). This will be a Tier 1 Priority.
- Priority #7: ODFW Reform and Funding. Discussions of commission members and the Oregon Conservation Strategy will be updated. This will be a Tier 2 Priority.
- Priority #8: Statewide Green Infrastructure Efforts and Floodplain Protection. Discussion included Gov. Kotek's housing bill; photovoltaic development in high-value farmland; Community Green Infrastructure Grant Program; and possible shutting down of HPAC (Housing Production Advisory Council). This will be a Tier 2 Priority.

Carly Chin has been hired as the Advocacy Program Coordinator at the Bird Alliance of Oregon; she encouraged chapters to participate in Lobby Day at Salem.

Jayshaun Talbot provided an update on the Lights Out program – there are no recent surveys and no pictures since April. The low numbers in the pilot program were contrasted with the higher numbers of strikes in previous years (anecdotal observations). Jayshaun will give a presentation on the pilot program at the WVBS in 2025.

Luckiamute Banding Station has invited a small group of MWBA members for a visit to the banding station. Jayshaun will coordinate the visit with Joan Hagar and Dr. Josée Rousseau. The group size will be approximately 15 people.

Jayshaun has offered to write up conservation activities and headlines for FB or the MWBA website. Jayshaun will contact Sue Powell about the website.

Jayshaun provided an update on the Saw-whet Owl Project. No one has done capture work on these owls in over 20 years. The initial pilot work was in Fitton Green but was moved to McDonald/Dunn Forest. Jayshaun will present his findings at an April ASC/MWBA general meeting.

There was a brief discussion regarding the email forwarded to the MWBA board on 11/12/2024 by Jim Fairchild that included the text of a blog by Andy Kerr. Kerr is in favor of conservation groups changing their tax-exempt status from 501(c)3 to 501(c)4. Under this change, donors would not get a tax deduction for contributions to MVBA.

HESTHAVN: Ray Drapek reported that our hard-working volunteer, Susan Nicholas, will be leaving the area. Steve Cook's association with the GI-300 program ended a while ago and a new instructor took over. Ray is concerned about the continuity of the program. A young student (Madeline) has been volunteering and brought friends to one work party. The solar composting toilet has a new paint job, courtesy of Ann Brodie, Madeline, and Ray.

Julie Gibson has planted \$500 of native plants on the Hesthavn grounds adjacent to the fenced area.

FIELD TRIPS: 2025 multi-day trips are being organized.

MEMBERSHIP: Bill Gellatly reported that the 2024 Annual appeal letter was mailed.

CBC: Bev Clark reported that the CBC will take place on December 17. She is assigning sectors to teams. The wrap-up dinner has been revived, thanks to Ann Brodie who reserved a room at the C3. The space has kitchen facilities. Ann and Mai Kiigemagi are coordinating volunteers who will bring chili for the main dishes. Attendees are asked to bring side dishes,

their drinks, and tableware and, if possible, to arrive early to help set up the room.

OLD BUSINESS - SCHOLARSHIP COMMITTEE REPORT: Jayshaun reported that the committee will be focused on the spring 2025 OSU term. Carolyn P., Mai, and Jayshaun will work on the committee. Carolyn suggested a faculty member participate on the committee. Jayshaun will reach out to OSU research community members to ask if they want to participate.

OLD BUSINESS - NAME CHANGE TASKS REPORT: Karan has reached out to the Bird Alliance of Oregon. Carolyn has taken responsibility for the paperwork and submittals to the State of Oregon and the Federal government; Don Boucher has agreed to do a basic design and will help guide the project for the new MWBA logo. Don will research possible artists to confirm their interest in a commission for the project. Dodie W. and Jayshaun T. also said they could assist in finding an artist if their help is needed at a future date. Discussion of the type of banner was shelved until the board selected a design for the logo.

Next meeting will be held at Dave Mellinger's home.
